There shall be no obligation on UNINET's part at any time to resort for payment to BUYER or resort to any collateral security, property, liens or any other rights or remedies whatsoever and UNINET shall have the right to proceed against GUARANTOR immediately upon any default by BUYER.

GUARANTOR further agrees that this shall be an absolute and unconditional personal guaranty of payment and that it shall be continuing and shall remain in full force and effect until written notice by registered mail of its discontinuance shall be actually received by UNINET at its principal place of business at 3232 West El Segundo Boulevard, Hawthorne, California and also until any and all such indebtedness, obligations and liabilities, existing before receipt of such notice shall be fully paid.
